Bids will be opened in the Board Room of the County Commissioners and read aloud at said time and date. All interested individuals are welcome to attend.

All bids shall be presented or otherwise delivered to the Commissioner's Office under seal with a concise statement marked on the outside thereof identifying the project to which the bids pertain. The SCOPE of the project includes site demolition, grading, parking lot asphalt, curb, sidewalks and related facilities shown in the Construction Documents.

All bids shall contain one of the following forms of Bidders security in an amount equal to 5% of the total Bid amount, made payable to the Kootenai County: a) Bidder's Bond executed by a surety company qualified to conduct business in the State of Idaho, b) Certified Check, c) Cashier's Check, or d) Cash.
