Separate sealed Bids for the Bid of NKWD Avondale / Pt Hayden Waterline Project will be received by NKWD at their office located at 1841 W. Hayden Avenue in Hayden, Idaho, until **2:00 p.m.** (Local Time), on **Wednesday, April 14, 2010** and then at said office publicly opened and read aloud. All interested individuals are welcome to attend.

BASE BID: The project consists of:

Avondale Phase 1: Construction of approximately 20,000 lineal feet of 8-inch and 10-inch waterline running along Avondale Loop, Kensington, Trafalgar, Avon Avenue/Circle and Merman. Also includes construction of four pressure reducing valve stations and installation of two check valves.

Point Hayden: Construction of approximately 4,200 lineal feet of 6-inch waterline running along Point Hayden Drive and Lake Forest Drive.
